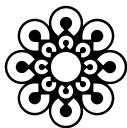

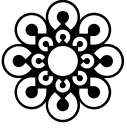

## **Moreno Valley Alzheimer's Support Group Announces its First Meeting: Wednesday, May 23**

MORENO VALLEY, CA – Families and individuals whose lives have been touched by the devastating effects of a loved one suffering from Alzheimer's Disease will have the opportunity to join an Alzheimer's Support Group, sponsored by Integrated Care Communities. The support group will not only emphasize and encourage member interaction, personal expression, idea sharing, and supportive communication, but will also feature a variety of special guest speakers, including medical professionals offering helpful information and advice about the emotional and physical challenges of dealing with Alzheimer's.

As a non-profit public/private partnership eligible for FHA-insured, low-interest government financing, ICARE is uniquely able to charge extremely competitive and affordable rates to its customers.
